We are sorry and we stand with you



We, gathered at the 2017 National Constitutional Convention, coming from all points of the southern sky, make this statement from the heart: Our Aboriginal and Torres Strait Islander tribes were the first sovereign Nations of the Australian continent and its adjacent islands and possessed it under our own laws and customs. This our ancestors did, according to the reckoning of our culture, from the Creation, according to the common law from 'time immemorial', and according to science more than 60,000 years ago. This sovereignty is a spiritual notion: the ancestral tie between the land, or 'mother nature', and the Aboriginal and Torres Strait Islander peoples who were born therefrom, remain attached thereto, and must one day return thither to be united with our ancestors. This link is the basis of the ownership of the soil, or better, of sovereignty. It has never been ceded or extinguished and coexists with the sovereignty of the Crown. How could it be otherwise? That peoples possessed a land for sixty millennia and this sacred link disappears from world history in merely the last 200 years? With substantive constitutional change and structural reform, we believe this ancient sovereignty can shine through as a fuller expression of Australia's nationhood. Proportionally, we are the most incarcerated people on the planet. We are not an innately criminal people. Our children are aliened from their families at unprecedented rates. This cannot be because we have no love for them. And our youth languish in detention in obscene numbers. They should be our hope for the future. These dimensions of our crisis tell plainly the structural nature of our problem. This is the torment of our powerlessness. We seek constitutional reforms to empower our people and take a rightful place in our own country. When we have power over our destiny our children will flourish. They will walk in two worlds and their culture will be a gift to their country. We call for the establishment of a First Nations Voice enshrined in the Constitution. Makarrata is the culmination of our agenda: the coming together after a struggle. It captures our aspirations for a fair and truthful relationship with the people of Australia and a better future for our children based on justice and self-determination. We seek a Makarrata Commission to supervise a process of agreement-making between governments and First Nations and truth-telling about our history. In 1967 we were counted, in 2017 we seek to be heard. We leave base camp and start our trek across this vast country. We invite you to walk with us in a movement of the Australian people for a better future.

Hawkesbury Area Women's & Kid's Service Inc. The Women's Cottage

In 1983, The Cottage opened its doors for the first time in premises at Windsor Street, Richmond. In 1986, The Women's Cottage moved to its current premises here at 22 Bosworth Street, Richmond. Over the years the Cottage has grown, along with the population in the Hawkesbury. There are currently 9 part-time staff and relief workers, wonderful students and volunteers that support the work of The Cottage as we strive to provide services and support for Women. 37 years and counting!

The Women's Cottage is a place where all women, regardless of age, class, race, religion, or sexual preference, are valued and treated as equal. It is a place for women to nurture themselves, a place of safety, and a place to learn and grow. It is a place for all women. It is a place that believes that access and equity are more than ideas and principles, they drive how we operate and what we offer.

The Women's Cottage is an information, resource, referral, advocacy and crisis support service for women and children living, working, and/or studying in the Hawkesbury. Family and Community Services (now operating under the new NSW Department of Communities and Justice) funds our Domestic Violence Support Project, Anti-violence work, 'drop-in' support, advocacy and referral services and two group programs. All other group programs are self-funded and reliant on past, present (and future) community donation.

The Women's Cottage also received funding from the Department of Social Services (DSS). Initially to provide support services to women effected by the work of the Royal Commission into Institutional Responses to Child Sexual Abuse, which evolved into the formation of a new National Redress Support Project. This project provided specialist counselling / casework support to women considering making a claim application for redress. The National Redress Scheme started July 2018 and is set to run for 10 years. This new project covers from Parramatta to Lithgow but does not turn away out of area requests for assistance. In these situations, we work women via phone and Skype while connecting them to services closer by and/or for an ongoing basis if local Redress Support Services are not available.

As a Feminist organisation, The Women's Cottage takes a strength based, trauma informed approach in all our work. Within the context of understanding social inequity, gendered nature of violence that impacts all women's lives. And through the Feminist framework lens that acknowledges and supports women's self-determination as the central expert in their own lives.

The Women's Cottage is committed to our role as advocate for social justice, for women and children in this Community.



Vision Statement

Hawkesbury Area Women and Kids Services Inc. is a Feminist community-based organisation that is run by women for women and children.

We are committed to all forms of freedom for women and children.

We are committed to an ecologically and socially just and diverse society, where all women are valued and treated as equal.

We are committed to assisting and supporting women and children to determine their own lives and choices.

We uphold women and children's rights to a safe environment whether within the home or in the community.

We actively pursue political measures to address the elimination of social and environmental oppression, injustice and violence, locally and globally.

Management Collective Report 2018 – 2019

The past year has been a busy time for the Management Collective. New programs, new funding, new areas of accountability all needed to be established, along with the accountability, reporting and related systems.

New Manager, Maria Losurdo, continues to make great strides steering The Women's Cottage from strength to strength. So much so that client numbers in some areas have doubled! A great outcome and one that comes with the challenges of how to support the extra pressures on staff and the financial pressures of trying to meet increasing demands on limited funding. In response a decision was made to draw on reserves to meet as many client needs as possible.

Other significant governance issues in 2018 to 2019 included the TEI funding reforms, ongoing policy development and increasing the number of members on the Collective. On that note we warmly welcomed new Collective members Janine Madden, Jude Irwin, Sonya Parker and Lisa Bartels. And said farewell and thank you to Lisa Minchenko, Lisa Parker and Sandra Coles Stokes.

The TEI reform was challenging due to changing guidelines and timeframes, implementation delays and uncertainty if it was to go ahead. Once clearer, The Cottage mapped current service provision to align to TEI, with strong advocacy for critical needs for ongoing services for women with older or no children.

One of the challenges of being a service with an almost 40-year history is the updating of policies that were originally written in the 1980's. An important issue in this regard was the need to review the Constitution to ensure all minimum standards contained in the model rules were covered. We thank Meg Keith for her time and attention in comparing and identifying gaps that need to be addressed. As at June 2019 a decision was made to delay the final revision of the Constitution until after a visioning day for Collective and staff on 'What does it mean to work in a Feminist service today?' From there any updates to our philosophy and structure will be included and the new draft Constitution that will be presented to members via a special general meeting.

Again, The Women's Cottage would like to thank the Hawkesbury Community for all the donations and support you have offered us. 'Thank You'. And a special thank you to staff, volunteers and students for all their hard work keeping The Women's Cottage services going and making it so vibrant and responsive to women's needs. Thank You.

Manager's Report 2018 – 2019

It continues to be a great joy and privilege a year on as I write my second manager's report. I think the best description for this past year is one of consolidation and growth. With all staff, students and volunteers working tirelessly and professionally to build up services offered at The Women's Cottage, deepen connections to the community and to respond to women using the service. As a result, the number of women using the service / seeking assistance has almost doubled this past year!

Groups: We have now established a full group program that runs every school term. A mix of groups are offered to provide both direct support for the impacts of domestic violence and other forms of trauma as well as soft entry groups that support a sense of belonging, connection and safety. This offers women the opportunity to get to know the service, the workers and what we offer. This is an important option for women to have, as many women then go on to seek advice and support for more serious concerns, they have not yet spoken to others about, once they feel safer to do so. Providing childcare for groups is also an important feature of our group program as it supports access. Group programs and childcare are mostly self-funded by The Women's Cottage and reliant on past and future community donations. *Please support us so these wonderful groups can continue.*

This year we ran 14 groups and 106 sessions were run. Attendance by session = 426 women!

- Yoga for women on low income partnership with The Yoga Shed
- ♥ Your Hero Journal Writing

Partnerships: I have made it a priority to connect with other local services and groups this year to promote the work of the Woman's Cottage and explore opportunities for working together to support the community. Membership and participation with HUBS (Hawkesbury Unites for Better Services) has been a great way to do this, as has becoming a local representative for LCSA (Local Community Services Organisation) as the resourcing peak body for community centres.

The Team: I can't speak highly enough of the women working for best outcomes for other women here at the Cottage. Their work practice is always first rate and they support me and each other really well. *Meg, Mel, Kim, Melissa, Angie, Sarah, Lauren, Amie and Sophie I say "THANK YOU".* Support received from the Management Collective is also appreciated.

Watch This Space

Several big changes sit on the horizon for the Women's Cottage:

TEI Reform: Targeted Early Intervention (TEI) reform is being applied to all areas of FACS funding. This means that the services we currently provided under FACS funding need to be aligned to these new funding criteria. To this end we have mapped how we see our service provision fit under TEI, communicated our thoughts and concerns to ensure services for women without children are still funded and supported by the Department and attended data collection training for the new DEX system that will apply to all TEI funded services. As at July 2019, the TEI transition process had been delayed. We are now waiting to work with FACS around our mapping plan and find out when TEI will officially begin. Advocacy for continued support for women without children is ongoing.

Building Grant: In 2016 The Women's Cottage applied for a \$75,000 cost matching capital expenditure grant from FACS. This application was extended to 2017 and completed in the early stages of 2018. In late April 2019 we received word this grant had been successful! Next step involves working with Hawkesbury Council as owners of the building and with the community to raise funds and support to make the dream of extending the Cottage a reality. This increase of space, rooms and facilities will greatly relieve current issues of overcrowding and limited capacity to meet increasing community needs or increase staff numbers / services offered.

Regional Partnerships: Much work was done through HUBS (Hawkesbury Unites for Better Services) in 2018 – 2019 to strengthen relationships and build capacity for exploring areas for joint response to local issues and maximize on the benefits of collective impact principles and practice. In June 2019 HUBS made a commitment to work together with the aim of reducing loneliness across the Hawkesbury region. It is widely recognised that loneliness can be the cause of many long-term health concerns and poor health outcomes. Including depression, anxiety, social isolation, higher risks of suicide, many chronic health issues.

Sustainable Development Goals: The United Nations globally and here in Australia have committed to 17 Sustainable Development Goals (SDG's) to address the world's most pressing human and environmental issues. The Women's Cottage was introduced to the SDG's in June 2019 at the LCSA Conference. The LCSA is encouraging member services to both recognise where they already contributing to these goals and where those efforts might be strengthened. The Women's Cottage has begun this process in earnest, and we are excited about what the future holds here.

Thinking Globally / Acting Locally: UN Sustainable Development Goals

At The Women's Cottage, we recognise the valuable role we play by providing a community centre that offers women and children a place to go where they can get information, support and where they can experience a sense of belonging and safety. For many women, who have not experienced this before in their lives, this offers a new window of possibility into what they deserve and could have for themselves and their family. The Women's Cottage also recognises the importance of standing for the rights of all women in the community regardless of race, religion, sexuality, lifestyle, family make up, and for women with and without children.

The work done at The Women's Cottage is not only vital for supporting the rights and safety of women and children locally, but it is also in line with efforts to improve conditions and lives all around the globe. The Women's Cottage Vision, formally includes to 'Actively pursue political measures to address the elimination of social and environmental oppression, injustice and violence, locally and globally.' In the coming years we will as a service work to strengthen our awareness and capacity by using the United Nations 'Sustainable Development Goals' (SDG's) as a framework for what we do and what outcomes are achieved. As a newly registered member to this global movement through LCSA, our results will feed into and be captured by United Nations in Australian and globally.

The United Nations describes the Sustainable Development Goals as the blueprint to achieve a better and more sustainable future for all. They address the global challenges we face, including those related to poverty, inequality, climate, environmental degradation, prosperity, and peace and justice. The Goals interconnect and in order to leave no one behind, it is important that we achieve each Goal and target by 2030.



Where does the Sustainable Development Goals journey start?

The Women's Cottage is committed to deepening our understanding of the 'Sustainable Development Goals'. We are identifying where our work already supports these goals, and where we can strengthen our capacity and achievements moving forward. This will include how to best strengthen partnerships with others to support positive collective impact. As a community centre we will work with peak body LCSA to establish formal participation in and reporting back to the United Nations SDG's Program.




A Window Into Our Centre Based Service Delivery 2018 – 2019


How Much Did We Do?



Outcomes for Clients, What Difference Did We Make?

Our work supported clients to achieve self-determination and positive outcomes. Results are drawn from client feedback, worker observations and casework conversations. (Sample size - 250 clients).



It is important to note that the reduction in safety outcomes is directly linked to the major increase in the number of women we are seeing who are in serious ongoing Domestic Violence where they remain at risk and are not safe.


Groups 2018 – 2019

The Women's Cottage runs a range of group programs every year. Groups that are offered are aimed at giving women an opportunity to:

- Be supported for a specific issue of distress, i.e. impacts of domestic violence and trauma.
- Develop self-care and emotional self-regulation skills and confidence.
- © Connect with other women and share strengths and stories of survival.
- © Grow in a sense of belonging to and participating in the community.

Most importantly, Groups provide a soft entry point into other support services that might be needed. This has been a significant factor in the numbers of women reaching out for help doubling this year.

FACS funds 2 groups each year. All other groups are funded by The Women's Cottage and Community Donations.






Centre Based Projects and Group Activity Reports



WAVE Annual Report 2018-2019

The last twelve months in the WAVE role has been busier than we can ever recall, the volume of Women using the WAVE Service feels like it has doubled, our workload has increased and many more hours are being spent on each Women – face to face and in the background (completing notes, referrals, support letters, advocacy and liaising with other services).

What Kim and I have noticed is that the complexity of Women's needs that they are presenting to us has increased immensely. One example being how many Women are coming in for support around NDIS, these Women report feeling overwhelmed and having their specific needs minimised by the process they are required to adhere to either apply for or when they do get a NDIS package.

The number of Women attending our Service for support due to Domestic Violence has overwhelmingly increased. We have noticed an increase in Women reporting technological abuse (social media, excessive calls and messages and their partners being able to track

their exact locations daily). We have also had an increase in referrals from Hospital Social Workers supporting Women who have been hospitalised after an assault. We have also had an increase in Women from CALD backgrounds and those with only temporary Visas, requiring support due to domestic violence

The groups at the cottage have been well received this year and attendance numbers are way up on previous years, it's been refreshing to see such a diverse range of Women accessing our Service to attend the groups.

Case Study

We had a young Woman arrive at our service with her Children in a distressed state due to Domestic Violence. It was too unsafe for her to go home and she had nowhere else safe to go. We were able to provide them safe accommodation through our Gabrielle Fund (which relies on donations as it's not funded). The Gabrielle Fund is specifically for this kind of assistance it was set up in honour of a local women killed by her partner despite seeking help. In being able to provide this service the Woman did not have to go through the trauma of calling other services for emergency accommodation for one night and having to re-tell her story.

She came back into our service the next morning and we were fortunately able to secure her safe accommodation in a Refuge where she and her children would receive the ongoing necessary support to re-establish their lives.

Anti-Violence Project Report 2018 – 2019

The Anti-violence Project Worker takes a key role in community development and education projects and activities that raise awareness about the effects of violence in communities; to work towards a reduction of violence against women and children; and to represent and involve The Women's Cottage in local anti-violence events and campaigns. This position also involves front line work providing crisis support, offering information and making appropriate referrals.

As an Aboriginal worker my role expands to offering cultural support to clients, The Women's Cottage, our partnering services and networks and to the broader Aboriginal Community.

Centre based activities included developing the programs and facilitating groups: Women's Drop-in Circle Group; Foster Carers / Kinship Carers Support Group; and Reclaiming Life (After DV) Group. I also provide short term DV case management and support for WAVE and drop in clients where needed.

Community work includes attending and participate in relevant networks and developing and sustaining partnerships with key government and Non-government services and workers.





Redress Support Project Report 2018 – 2019

The National Redress Scheme was a key recommendation of the Royal Commission into Institutional Child Sexual Abuse, has been established to provide financial redress and other support services to those who have experienced sexual abuse within an institutional context.

I accepted the interim position of Redress Scheme Specialist Counsellor/Case Worker role in August 2018, just one month after the launch of the National Redress Scheme in July. The project is currently funded until June 2021. Permanent positions were advertised in March 2019 and Sarah Dillane now make up the Redress team at The Cottage.

Work at The Cottage is underpinned by Trauma Informed Care approach and Feminist work principles. From the moment we open the door or pick we are working within a 'strength-based framework' responsive to the effects of trauma. This intentional approach is also at the heart of the Redress Specialist Support we offer women considering application to the National Redress Scheme.



Setting up the service has been a very full experience. I can honestly say there has never been a dull moment since I began work. We provide assistance to women, from Parramatta to Lithgow, Hawkesbury and Blue Mountains area. Women seeking information, practical and emotional support around a Redress application can make contact with our service, face to face, by phone, with a friend or family member. We can also make home visits and work collaboratively, with other services to provide outreach support. In our first six months, it was interesting to note that half the enquiries we received, were from women who lived guite a distance outside our funded area. Women were drawn to contact the only women specific service listed on the Redress website. This highlights the emotional barriers many women have to overcome, to make that first step to look up the website and then find the courage call to a support

service. We have made the decision to 'turn no one away'. We will and support women from outside our area, for as long as it takes to arrange appropriate support from another Redress funded Support Service in their own area. Other highlights include setting up IT, phones and networked capacity to work in the field; tackling (and winning) with DEX Federal data collection systems and setting up our office space with beauty, safety and trauma informed spaces in mind.

As well as supporting women through the application process at their own pace, the role includes promoting the Redress Scheme at Inter-agencies, team meetings and other groups. We have offered information sessions in Central West, Blue Mountains, Penrith and locally. Services visits have been made at Blacktown Women and Girls Service, Merana Aboriginal Service, Hawkesbury Aboriginal Outreach, Katoomba and Springwood Neighbourhood Centres, Thrive Family Services Katoomba, Lithgow Community Projects, Penrith Women's Health Centre and The Wash House. We have developed strong collaborative relationships with Penrith Women's Health Service, The Wash House in Mt Druitt, Rape/DV Crisis Service, Interrelate, Miranda Project and Richmond Family Services.

Integral to the work we do in supporting women through the Redress process is managing their expectations of the Scheme and the triggers that can come up through this process. We use many creative techniques to promote safety, positive experiences and resilience in face to face work and also in group work. Our clients are encouraged to be involved in any of the groups at The Cottage and we facilitated a Redress specific group called 'Wrapped in Angels', a 10-week program supporting healing and building resilience, created by Mc Veigh, from Cara House. Three Aboriginal Redress clients took



part in this first group, creating their own personal blankets filled with images, symbols, messages, words, colours and textures that spoke to them of hope, strength and inspiration. Snippets of this work is shown in these photos. It was a privilege to be part of this group and notice over time how the women took ownership of the group, talking more freely and supporting each other. This was the first of many WIA groups we hope to run to support women on their Redress journey.



The Women's Cottage was invited by the Parra Girls Precinct director Bonney Djuric to act as emotional support to the Women attending the Apology Day event at Parramatta Girls' Home on 22nd October 2018. It was a great honour to be asked to walk alongside women attending the event, many who were returning to the Girls' Home for the first time since childhood. We continue to support events and women from Parramatta Girls' in relation to Redress Scheme questions and offering general support.

Sarah and I keep abreast of current training in trauma practice and related areas. Between us, we have attended excellent training in this area in 2018 – 2019, including:

- 3-day Wrapped in Angels Facilitator Training Alys McLellan (Cara House) and Maria Losurdo.
- 3-day Blue Knot Foundation: Working Therapeutically with Trauma I & II
- 2-day Aboriginal Cultural Training at Merana Educator Sigrid Herring
- 2-day National Redress Scheme (DSS & DHS) Community of Practice Forum, Melbourne
- Know More Training on Legal aspects of Redress scheme with Anna Swain/ Prue Gregory

We are active participants in the NSW Providers Redress Support Services, bi-monthly Teleconference meetings and local Practitioner Forums. And we also attended a two-day Community of Practice Forum, in Melbourne. This was a great opportunity to meet with Redress Support Services from across Australia and listen to stories of the strengths and challenges, including hearing from Aboriginal services working on Redress applications with clients living in remote areas where English might be their 3rd or 4th language!

And finally, a big acknowledgement of the support of our service manager Maria Losurdo, who supports our work with much insight and experience. A big thank you also to all our co-workers and colleagues for the support they have given us throughout the year. Working together is our strength.

2019 FINANCE REPORT for HAWKESBURY AREA WOMEN'S & KIDS SERVICES COLLECTIVE INC The Women's Cottage

It has been an eventful year for the Cottage, with continuing recurrent funding from the Department of Family and Community Services and the Department of Social Services as well as a matching grant for building extensions and donations for programs being received.

The Cottage operated at a loss for the year of \$10,712, however we continue to be financially secure with equity carried forward of \$112,455.

As usual, our main source of income was our recurrent funding from NSW Department of Family & Community Services (FACS), and the funding from the Department of Social Services for both the Royal Commission Support project and the Redress Scheme Support services.

The Cottage was fortunate to receive a matching fund grant from the Department of Family and Community Services of \$75,000 for Building extensions. The Cottage will need to match these funds by either retained funds or donations from the community and in-kind donations of materials and labor before the building works can go ahead.

Donations from the community in support of the Gabrielle Fund, Emergency Relief, Christmas Hampers and the work of The Cottage totaled \$9,425.

Bank interest for the year from all the Cottage's accounts including Term Deposits was \$5,811 Interest rates have continued to remain low effectively reducing this source of income.

It is a privilege to be part of the team at The Women's Cottage. A wonderful team made up of fellow staff, volunteers and Students. I look forward to many more years working here with this team of compassionate and resourceful women.

Notes to and forming part of the accounts For the year ended 30 June 2019

Note 1. Statement of Significant Accounting Policies

The financial report is a special purpose financial report that has been prepared for the use by the members of the Association in order to satisfy the reporting requirements of the Associations Incorporation Act (NSW) and in accordance with Australian Accounting Standards.

The financial report covers Hawkesbury Arm Women & Kida Servicus Collective Inc. as an individual entity.

The following is a summary of the material accounting policies adopted by the Association in the preparation of the financial report. The accounting policies have been consistently ambied unless otherwise stated.

A) Basis of proparation

The financial report has been prepared on an accruals basis and is based on historical cost and does not take into account changing money values or, except where stated, current valuations of non-current assets for which the fair value basis of accounting has been applied.

B) Accounting Policies

a) Pinnt and Equipment

Back class of property, plant and equipment is carried at cost less, where applicable any accumulated depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed samually to ensure it is not in excess of the recoverable amount from those agets. d) Previsions

Provisions are recognised when Howkesbury Area Women & Kids Inc. has a legal or constructive obligation for which it is probable that the outflow of economic benefit will result and that the outflow can be measured privably. The Committee has determined that these outflows are adequate

c) Cash and Cash Equivalents

Cash and each equivalents includes cash on hand, deposits held at call with banks or financial institutions, short term his ally liquid investments and bank eventually.

f) Revenue

Interest reverse is recognised on a proportional basis taking into account the interest rates applicable to the financial asset.

Revenue from the rendering of service is recognised upon the delivery of the service to the customers.

g) Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

APPENDIX 3: How Can You Help?

How can you help? So glad you asked!

The Women's Cottage is only able to provide the extent of the services we do, the emergency relief and food supplies, and a full group program with the support of our local community. If you or your agency can support us in any way to help us support vulnerable women and children that would be wonderful.

Christmas Appeal (Hampers and Toys):

- You could give a cash donation or foods suitable for a Christmas hamper.
- You could buy a gift for a child for Christmas and drop it in (we find it especially hard to get enough gifts for older children 12 – 16).



• You could set up a Christmas tree / gift box at your work and encourage others to donate something as well.

Emergency Relief & Food Supplies: You could give a cash donation or non-perishable food supplies to help fill our food shelves for families struggling financially.

Building Fund: The Women's Cottage has received funds to help us extend the building to increase space and capacity to meet the expanding community needs we are trying to meet. To make this a reality we must match these funds (at least \$75,000 in cash or kind) to move ahead with the project. There are lots of ways the community can help:



- Individual donations or group fundraising.
 Could be an open donation or you could nominate specific things, eg: furnishing new group room / children play area.
- Local businesses and trades people donating time and materials for the demolition or building costs, furnishings, carpets, blinds, desks, IT connections, painting etc.

Responding to Domestic Violence:

The number of women seeking help in relation to escaping domestic violence has doubled in the past year. The complexity and risks faced by the women is also increasing. We often see women where police involvement is urgently needed, where there are guns involved, where we need to keep women safe at the cottage until Police arrive and/or where women and children are unable to safely leave and have their movements controlled or monitored.



Gabrielle Fund: Your cash donation will help us assist women escaping domestic violence.

Group Programs: Most of our group programs (currently attended by over 400 women each year) are funding solely by community donation. Any money, even the smallest amount, can support us continue to run a full group program and support women with a soft entry point to more support if needed.

If you want to run a fundraiser you might be able to raise enough to fund a whole group and you and/or your group, service or business can go on our sponsors list. A 10-week group costs us around \$8,000 to \$10,000.

Crisis and Counselling Support: We do not have the resources or worker time to meet current and growing needs for the number of women seeking safety from violence. Business, group or community fundraising efforts will help us meet these needs.
